3. Body-Worn Cameras for SJPD Officers

- b) Begin preliminary research to identify potential sources of funding to implement a body-worn camera program to assist in the costs associated with purchase of hardware, digital storage and device maintenance.

- c) Once staff has developed a recommendation as to whether and how body-mounted cameras should be implemented, based on stakeholder engagement and professional staff analysis, bring the staff recommendation forward to Council for action.

Public Comments: Martha O'Connell, Johnny Le, Richard McCoy, David Wall and Jim Piazza objected to the disqualification of Martha O'Connell's application to the Housing and Community Development Commission.

Chief Deputy City Attorney Patricia Deignan and Assistant Housing Director Jacky Morales-Ferrand responded to the Committee's questions.

Discussion: The Committee had a brief discussion and made recommendations for clarifying appointments by Councilmembers and quorum rules.

Actions: Upon motion by Councilmember Constant, seconded by Councilmember Oliverio, and carried unanimously, the Committee directed the City Attorney's staff to return with an amendment to the Municipal Code on the consolidation of the Housing and Community Development to 13 members; 11 City Council appointed members plus 2 required members (mobile home park resident and mobile home park owner) nominated by the Council Appointment Advisory Committee and approved by City Council. (3-0-1. Absent: Reed).

Upon motion by Councilmember Constant, seconded by Councilmember Oliverio, and carried unanimously, the Committee directed staff to return to City Council at some point in the future to discuss quorum rules. (3-0-1. Absent: Reed).
